2. **Official Academic Documents** - Please request the registrar or records office of your previous institution(s) to mail or email your official academic documents directly to our New York City office. Our email address is verification@spantran.com.

Alternatively - If your previous institution(s) cannot send your documents to SpanTran, you or a third party may mail the documents instead. PLEASE NOTE: Your documents must arrive in an official, sealed university-issued envelope. The envelope should be stamped and signed by the university or college. Your documents should also be stamped and signed by the registrar or appropriate officer. Your evaluation will then be completed and issued only to Heinz College.
